This has reference to our intimation dated 30^{th} May, 2025 with respect to re-appointment of the Secretarial Auditors of the Company in the Board Meeting dated 30^{th} May, 2025.

Please note that in the Board Meeting dated 30th May, 2025, Mr. Sonesh Jain of M/s. Jain Sonesh & Associates, Practicing Company Secretaries was re-appointed as the Secretarial Auditor of the Company for one term of 5(Five) consecutive years effective from 01st April, 2025 to 31st March, 2030, subject to the approval of the shareholders in the ensuing Annual General Meeting of the Company.

Further, the Board of Directors of the Company at their meeting held on Wednesday, 03rd day of September, 2025 considered and approved the Re-Appointment of Mr. Sonesh Jain of M/s. Jain Sonesh & Associates, Practicing Company Secretaries as the Secretarial Auditor of the Company for a period of 1 (One) Financial Year i.e. 2025 -2026 in compliance with Regulation 30 of SEBI LODR.
